Real-Time Collaboration Network The Consumer Product Safety Improvement Act (CPSIA) of 2008 requires that nearly all children's products comply with all applicable children's product safety rules. These products must be tested for compliance by a CPSC accepted laboratory and have a written Children's Product Certificate (CPC) that provides evidence of the product's compliance. The act requires that all children's products have permanent tracking information affixed to the product and its packaging.

The CPSIA also requires U.S. manufacturers or importers of non-children's products where consumer product safety rules, standards, or regulations are enforced by the CPSC to issue a "General Certificate of Conformity" (GCC). The GCC must be based on a test of each product or a reasonable testing program. The act is complex, evolving and can be costly to manage without the right solution in place.
